Entry into the Promotion is deemed acceptance of these terms and conditions:

Eligibility

- 1. To be eligible to enter, you must be:
 - 1. an individual who is 18 years or over; and
 - 2. a Australian resident who is eligible to connect a service at a property in Australia.
